Massachusetts Historical Commission Accepting Applications for MA Preservation Projects Funds Grants

The Massachusetts Preservation Projects Fund (MPPF) is a state-funded 50% reimbursable matching grant program to support the preservation of properties, landscapes, and sites (cultural resources) listed in the State Register of Historic Places. The Massachusetts Historical Commission (MHC) has announced Round 30 of the MPPF grant program; municipalities or nonprofit organizations are invited to apply for funding for planning and predevelopment projects, construction activities for historic preservation, and acquisition projects. Applications are due by March 15, 2024. Learn more and apply.

Community One Stop for Growth FY25 Expression of Interest Now Open

The Healey-Driscoll Administration recently announced the opening of the FY25 One Stop Expression of Interest (EOI) application. The EOI is a short, online form that gives prospective applicants the opportunity to receive guidance on priority projects before submitting a Full Application. The deadline for submitting an EOI is April 30, 2024.

While optional, all applicants who submit an EOI will receive a Feedback Report letting them know whether their project is a fit for the funding offered through the One Stop, where the project falls on the Development Continuum, the program that best fits the project, tips on how to be

competitive for the program, and important project budget and timeline considerations. For FY25, twelve programs will be administered through One Stop, including the state's new https://www.housing.works.nfrastructure-Program—a competitive grant for infrastructure related activities to support and unlock housing opportunities.

Landscape Partnership Grant Program

Deadline: Thursday, April 18, 2024 at 3:00pm

The Landscape Partnership Grant program provides financial assistance for the protection of large blocks of conservation lands (must achieve protection for 100-500 acres depending upon the County in which the project is located) that promote ecological integrity and connectivity as well as contribute to local forest and agricultural economies. Applications must be submitted jointly by partners representing a minimum of two eligible categories of applicant such as municipalities, 501 c3 conservation non-profits (e.g. Land Trusts), State and Federal Land protection agencies.

An in-person information session will be held at 1:00pm, Monday, February 26, 2024 at MassWildlife Field Headquarters in Westborough, MA and a virtual meeting will be held via MS Teams at 2:00pm, Wednesday, February 28.
