The Executive Office of Economic Development recently announced the opening of the FY25 Inland Dredging Pilot Round of the Massachusetts Dredging Program. This round offers final design and construction grants to Massachusetts municipalities to support dredging of freshwater lakes, ponds, rivers, streams, and drinking water reservoirs, as well as dredging required for the removal of municipal dams. Applications are due via online submission no later than March 1, 2024, 11:59 pm.

### Massachusetts Historical Commission Accepting Applications for MA Preservation Projects Funds Grants

The Massachusetts Preservation Projects Fund (MPPF) is a state-funded 50% reimbursable matching grant program to support the preservation of properties, landscapes, and sites (cultural resources) listed in the State Register of Historic Places. The Massachusetts Historical Commission (MHC) has announced Round 30 of the MPPF grant program; municipalities or nonprofit organizations are invited to apply for funding for planning and predevelopment projects, construction activities for historic preservation, and acquisition projects. Applications are due by March 15, 2024. Virtual workshops describing MPPF grants and eligible projects are scheduled for January 17 from 10:00am to 12:00pm and January 24 from 2:00pm to 4:00pm Learn more and apply.

## 2024 Massachusetts Housing Partnership Funding for MBTA Communities Zoning Amendments

The Massachusetts Housing Partnership (MHP) anticipates receiving additional funding from the Executive Office of Housing and Livable Communities (EOHLC) that will allow the agency to continue to support communities in advancing zoning amendments that comply with MGL Chapter 40A, Section 3A (MBTA Communities Law).

The purpose of MHP's 3A-TA program is to connect technical assistance providers with planning staff and municipal officials to support activities directly related to the development, documentation, and community engagement in developing multifamily zoning districts that comply with EOHLC's Guidelines.

#### MassBike 2023 Annual Event

On December 5, 2023, Jessica Boulanger, NMCOG Transportation Mobility Specialist presented at the 2023 MassBike Annual Event. The virtual meeting was attended by Lt. Governor Kim Driscoll, Senator William

Brownsberger, Representative Tommy Vitolo, and Representative Michelle Ciccolo, and included a legislative panel providing suggestions on how to build more bike-friendly momentum on Beacon Hill.

Jessica shared how participants can get involved with their local Metropolitan Planning Commission (MPO) to support local bicycle infrastructure and discussed the Greater Lowell Vision Zero Plan. She was joined by MassBike Staff Alexis Hosea Abbott who recently developed a statewide <u>Bike Advocacy Group Directory</u>. ### MassDOT Announces \$100 Million in Fair Share Funds Distributed for Transportation Improvements

MassDOT recently announced the distribution of \$100 million in Fair Share Funds for Fiscal Year 2024 to municipalities to support local infrastructure. Fair Share Amendment funds are distributed according to two formulas: \$50 million is being distributed using the traditional Chapter 90 formula based on local road mileage (58.33%), population (20.83%), and employment (20.83%); another \$50 million is being distributed using a formula based on each municipality's share of road mileage.

Communities may use Fair Share revenue for construction, preservation, and improvement projects that create or extend the life of capital facilities. This includes costs for highway projects and pedestrian and bicycle facilities. Projects that are eligible would include installing sidewalks, bicycle lanes, new pavement, sidewalks, retaining walks, crossing signals, and other transportation infrastructure features.
